3. Do not tolerate corrupted behaviors and never accept all forms of corruptions.

5.1 Coordinate and cooperate in the implementation of the national strategy for the prevention and suppression of corruption, Phase 3 (2017-2021)

5.2 Coordinate and cooperate in creating networks to prevent and suppress corruption in educational institutions.

5.3 Participate in providing knowledge to teachers and educational personnel in schools to create knowledge, understanding and participation in campaigning for the youths, parents and the general public. In organizing anti-corruption activities and as a network to prevent and suppress corruption.

5.4 Participate in any other action in preventing and suppressing all forms of corruption with other agencies.
